

TERMS AND CONDITIONS

GUSTO Italian Language Course

Course Content:

GUSTO Italian language course consists of 33 hours total as seen in the course syllabus.

- 20 hrs. classroom which includes:
 - Italian language instruction/role-plays (3/4 classroom time),
 - Cultural Topics: discussion in English (1/4 classroom time)
- 13 hours of guided activities as shown in the course syllabus.

The course is a one-week course beginning Monday morning (Sunday arrival). A new class starts 2nd Monday and 4th Monday of EACH month. Additional Italian language hours are available for an additional fee. All the Artelingua teachers are certified, native-speaking Italians with many years formal teaching experience making learning interesting and fun. Artelingua teachers genuinely enjoy teaching.

Reservations:

To reserve a place, please send a request, either by email or using the Contact Us form on our Website, <http://artelingua.it/>. Artelingua will confirm your request by email within 3 working days. If your desired date is already fully booked, we will suggest alternative dates.

Please note: the small group classes are minimum 3 participants. This course is contingent on 3 students signing up.

You will receive detailed confirmation upon your written request.

Confirmation / Registration Fee:

The student will receive an email confirmation confirming the start-date and course fee.

Upon confirmation, the registration fee of €50 is due. This deposit is non refundable.

In the confirmation email, a link will be provided to make the deposit by PayPal. Other payment options are listed below.

If the student can not attend his/her course on the date confirmed, he/she must advise Artelingua 14 days before course begins, and the deposit can be applied to a new course date (providing there is a spot available).

Course Fees:

- Small Group (3 – 7 participants) € 550,00 per person
- Mini Group (2 participants) € 885,00 per person (great for couples or best friends)
- Individual (1 person) € 1029,00 per person

Payment of Course Fee:

The course fee can be paid in advance (see payment options) or can be paid on the first day of classes through PayPal or cash (Euros). The student will receive an invoice/receipt for all payments.
